## II. F-35: City of Boise

## • Discussion:

- The City is asking the neighborhood associations to wait until Gowen Field is selected as a potential site for the F-35 mission to take a position on supporting or opposing the mission.
- There is a concern about the noise pollution associated with the F-35
- o Gowen Field will host 2 F-35s in September or October.

#### Action Items:

## **III. West End Secession**

### Discussion:

- NA must contact people who would be affected by the secession and consult with them about how it might affect them.

- There are many reasons to split including the lack of participation from other areas of VPNA, the lack of a cohesive neighborhood with a unifying mission, the historical character of the "West End" and the numerous developments and projects impacting the West End that cannot be addressed when "West End" representatives are trying to support and represent other unrepresented areas of the neighborhood association.

 There was concern about the anticipated name "West End Neighborhood Association" and the historical validity of the name as well as the acronym associated with the name.

- Whittier Place A: Eleanor C, nominated by Alex; approved by the majority
- Park Davis: Brian K made a motion to have Don's representation moved to Park Davis; motion was approved by the majority.
